BYLAW NO. 490

A bylaw to amend the Regional District of Fraser-Cheam Bylaw No. 103, 1978, the Mobile Home Parks Bylaw.

WHEREAS the Regional Board of the Regional District of Fraser-Cheam has deemed it advisable to amend the Mobile Home Parks Bylaw No. 103, 1978;

NOW THEREFORE the Regional Board of the Regional District of Fraser-Cheam in open meeting assembled enacts as follows:

TEXT AMENDMENT

That Section 1.02 of Regional District of Fraser-Cheam I. Mobile Home Parks Bylaw No. 103, 1978, be deleted and the following substituted therefor:

> "This bylaw shall be applicable within the boundaries of the Regional District of Fraser-Cheam except;

- those areas lying within a village, town, city or district municipality, and
- those lands at Cultus Lake Park, separately (ii) administered by Cultus Lake Park Board, and
- those lands in Electoral Area 'C' outlined in (iii) red and cross-hatched on the map attached hereto as Schedule 'A'"
- That Schedule 'A' be an integral part of the bylaw and II. be inserted immediately after Section 13.05 of Bylaw 103, 1978.
- That this may be cited for all purposes as the Regional III. District of Fraser-Cheam Mobile Home Parks Bylaw Amending Bylaw No. 490, 1983.
